

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at the Office of **Kalaiya Sub-Metropolitan** Kalaiya Bara. Bids must be valid for a period of 90 after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the validity period of the bid.
